

Heroic Team Leads Triumphant Comeback

In mid-August 2023, life took an unexpected turn for 11-year-old Alec Goytia, a vibrant and active young man who loved playing sports, especially basketball. His world changed dramatically, Alec was weak, unable to get out of bed, and facing an uncertain future as he was diagnosed with Guillain-Barré Syndrome (GBS). Alec's journey towards recovery became a testament to the power of resilience, the support of a loving community, and the dedication of an incredible team of healthcare providers at Community Hospital.

Alec's health challenges were initially presented as flu-like symptoms including droopiness, vomiting, and headaches. Despite inconclusive results, his condition worsened, leading to leg weakness and prolonged bedridden days as the school year commenced at McCook's St. Patrick Elementary School. Numerous visits to the clinic and the emergency room, coupled with inconclusive blood tests, prompted healthcare providers to enlist the expertise of Children's Hospital in Omaha, marking the beginning of Alec's journey to recovery.

On August 17, Alec was admitted to Children's Hospital, where he received a diagnosis of GBS, which affects the peripheral nervous system. Celebrating his 12th birthday within the hospital walls, Alec exhibited remarkable positivity and resilience throughout the treatment process, navigating feeding tubes, IV fluids, and an extended hospital and rehabilitation stay at Madonna Rehabilitation

Hospital. Physical and occupational therapists at Madonna began working out Alec's muscles, rebuilding what was once strong and sure. After 65 days of intense recovery, in early-October, Alec was finally able to leave and return home to McCook.

Alec's story stands out not just for the medical complexity, but for the extraordinary teamwork and dedication demonstrated by the healthcare providers at Community Hospital. The collaboration between the departments, including Outpatient Injection/Infusion, the Chaplain, and the Community Hospital Rehabilitation Center, showcases the importance of a continuum of care that Community Hospital strives to provide to every patient.

The team at Community Hospital Rehabilitation Center were the first to work with Alec. Laren Roper, an occupational therapist at Community Hospital focused on addressing Alec's core weakness, emphasizing the importance of stability in Alec's overall recovery, stating "Improving core stability is foundational for individuals like Alec who face proximal weakness. It not only enhances their ability to perform daily activities but also lays the groundwork for more targeted interventions." Roper has concentrated on upper body rehabilitation, noting his arms were particularly weak. Working on everything from supported pull ups to trampoline ball throws, with an occasional pick-up game of basketball, Alec has slowly been able to go from an initial grip strength of 20 pounds

to about 50 pounds, and he has gone from being wheelchair-bound to excelling on his basketball team.

Because of Roper's ability to hone in on core support and upper body extremities, Community Hospital's Physical Therapy team, including therapists Brett Burton and Steve Thompson, assisted by Sarah McDonald, have been able to focus their efforts on Alec's lower extremity rehabilitation. They have incorporated innovative techniques into Alec's

regimen, including Blood Flow Restriction (BFR) Training. Burton emphasized the impact of BFR, stating, "Blood Flow Restriction Training is an innovative therapy within rehabilitation. By restricting blood flow to the muscles during low-intensity exercises, we can achieve significant gains in strength and muscle mass, even with limited weight-bearing capacity." Other impactful exercises have included rope pulling, side shuffling, sprinting, and squatting. Remembering Alec began physical therapy unable to lift himself from the ground without support, Burton has been happy to see so much progress. Outpatient Injection/Infusion has also been an integral part of Alec's recovery. Patients receive medications directly into their veins through IV administration. In Alec's case, every four weeks for about eight hours, he receives a medicine called intravenous immunoglobulin, or IVIG, which is a pooled antibody, used to treat autoimmune diseases, including GBS. They have seen remarkable success using this medicine with Chase Crawford, Community Hospital Pharmacist and Director of Outpatient Injection/Infusion, explaining that

Alec had his first IVIG infusion on October 16, by November 16 he had gone from a wheelchair to a walker, and by the beginning of December he was playing basketball. "For Alec, IVIG has been a game changer. Along with his work in the rehabilitation center and on the basketball court, his condition has significantly improved in a very short amount of time." Peg Smalley, registered nurse at outpatient injection/infusion, vividly recalled Alec's first infusion. "He arrived in a wheelchair, and my heart broke for him. I took the backseat and allowed Alec to take charge, giving him the opportunity to tell me how he preferred to receive the treatment," going on to say, "he's a fighter and wanted to get better from

the get-go." The Community Hospital Chaplain, Tyler Thiessen, sits with Alec during his infusion treatments to help pass the time and keep Alec's spirits up. They have built a friendship playing games and visiting, each looking forward to the other's visit.

Looking forward, Alec continues to set new goals, embracing physical activities like basketball and football drills. His ambition to become an athletic trainer reflects his determination to channel his experience into helping others. The support from his school, friends, and community has been pivotal in Alec's remarkable recovery, and he now looks forward to putting GBS behind him.

Medicare Advantage – Why not?

Since Blue Cross Blue Shield began selling its Medicare Advantage plan in Red Willow County, Community Hospital has been asked to join the network. We have repeatedly said “no.” This decision is made each year after assessing the product and the situation it creates. We understand that, for some, Medicare Advantage can be beneficial. We also know that, for many, it can be a nightmare. Not all Medicare covered services are covered by Medicare Advantage. Out of pocket costs are much higher than traditional Medicare when accompanied by a supplement. Once on Medicare Advantage for more than one year, you are no longer guaranteed a supplement. You must go through the full underwriting process to qualify and be rated. Therefore, when your health changes and the out of pocket costs catch up to you, you may not be able to go back to traditional Medicare. The protection may not be available to you anymore.

Another factor is that for a provider such as Community Hospital in rural America it can jeopardize access to care. Providers lose revenue and incur additional costs with these plans. This reduces the resources otherwise spent on providing the care patients deserve. Rates paid to providers are not the same as with traditional Medicare. Oftentimes, providers are paid less or not at all. Along with this,

providers have to employ more non-clinical staff to manage the process of pre-authorizations and the denials these plans have been proven to employ. According to the Department of Health and Human Services Office of Inspector General website, 13% of denials were deemed inappropriate. That means 13% of patients denied were refused appropriate care. As such, there is legislation and regulations that have been proposed and, in some cases, finalized to attempt to limit what these financial services companies like United, Humana, and BCBS, can do.

Most healthcare systems are in network for at least one, if not many Medicare Advantage plans. It was the result of competition between hospitals trying to maintain market share over another. When that started, Medicare Advantage was a much smaller portion of the pie. Now, it is significant. In 2023, it was over half of coverage provided to Medicare aged adults.

Given the problems already discussed with these products and many other issues not discussed, health systems and physicians are dropping these products and themselves from these networks at a quick pace. While noting Medicare Advantage carriers have faced allegations of billing fraud from regulators and probes by lawmakers over the high denial rates, health

systems have announced terminations to many, if not all, Medicare Advantage plan agreements. This includes Scripps of San Diego. They are dropping most plans. St. Charles Health System of Central Oregon is dropping all plans and actively encouraging seniors not to sign up for these plans. Mayo Clinic in Arizona and Florida announced to patients in late 2022 they would no longer accept most Medicare Advantage plans. The full list is too long to mention but this is a small sample of what you can find in the headlines and the list continues to grow by the month. In October, the Nebraska Hospital Association issued a report detailing how these plans are failing patients and providers especially in rural facilities and clinics.

My peers across the country ask me often, “how have you managed to keep them out of your market?” We simply said “no” as we refused to conform to what we understood years ago could eventually lead to where we are today, but we never say never. One day the rules may be effective to manage the issues created by these plans. One day these financial services companies such as BCBS, United, and Humana may update their ethical compass from pointing at profits to pointing at patients instead. If so, we will consider joining their networks.

HOSPITAL HEARTBEAT

Voices in Action by Diane Gumaer

One year ago, Community Hospital rebuilt its Patient and Family Advisory Council following a long hiatus due to COVID. The Council met ten times during its first year, learning about and reviewing hospital policies and procedures and offering feedback and recommendations to hospital directors and administrators. This group of local residents comprised of current or former patients and family members of patients, volunteer to serve on PFAC. They help ensure that community voices are present in hospital decisions, the focus being to achieve care that is truly patient- and family-centered. Four staff members also serve on the Council.

In discussions about their own experiences with Community Hospital, this group cited what they perceive as some of the hospital's strengths – including its extensive outpatient services, great obstetrics care, strong outreach programs for the community, kind and respectful staff, and exceptional home health and hospice programs. Among opportunities for improvement, they suggested things including creating more comprehensive discharge instructions for inpatients and Emergency Department patients, and enhanced

communication with family members of patients with advanced age or diminished mental capacity.

"I'm proud to be in a community where we have a hospital that offers so much more than most small towns and truly wants input from patients and families," said PFAC Co-Chair Judy McCune, Marketing Director at Kinship Pointe. She goes on to add, "It's important that we know about the efforts the hospital makes to best serve us and that we have a voice in suggesting improvements or enhancements."

During their first year, PFAC members hosted educational sessions and took action on various projects, including learning about the hospital's policies regarding safety, confidentiality, and infectious-disease control. They also heard from administrators about the Community Hospital mission, vision, strategic-planning process, action-planning process, and four seeds of success. The Council chose projects such as reviewing and making recommendations for parking and outdoor signage. They made



recommendations to improve discharge instructions. The Council created business cards and marketing enhancements for the hospital's Patient Feedback Hotline to ensure patients and families have a way to provide compliments and concerns. PFAC is reviewing the hospital's Age Friendly Initiative and will continue to provide input on Voice of the Customer strategic planning data. A PFAC Seal of Approval was created as a means of identifying projects that have been supported by the Council.

Bridging the Gap: Tackling Disparities in Rural Lung Cancer Screenings

Lung cancer continues to be a significant public health concern, with early detection playing a crucial role in improving outcomes.

Rural communities face unique challenges when it comes to healthcare access. Factors such as limited healthcare infrastructure, geographical isolation, and a higher prevalence of smoking contribute to the elevated risk in these regions.

Despite the proven benefits of early detection, only 10% of eligible patients undergo lung cancer screenings

in any given year. Additionally, a significant challenge lies in the lack of a structured process to ensure annual follow-up screenings. This gap in follow-up care can lead to missed opportunities for detecting cancer at its earliest and most treatable stages.

Recognizing the need for urgent intervention, the Healthcare Quality Improvement Program, Critical Access Learning Network has taken a proactive approach. This initiative seeks to extend the opportunity to all Critical Access Hospitals to participate in their Lung Cancer Screening.

Critical Access Hospitals, including Community Hospital, acknowledge their vital role in serving rural communities and prioritize these areas in initiatives to enhance access. Community Hospital actively encourages individuals in the region to consult their local providers to learn more about low-dose CT lung cancer screenings. As awareness expands and efforts to improve access gain momentum, there is optimistic anticipation for a future where universal early detection of lung cancer becomes a reality, leading to improved outcomes for individuals in rural communities.


